




Treasurer's Report

Alan Stratton, Treasurer

- Healthy operating performance for the year ended December 31, 2022 as programming and facility use recovered from pandemic restrictions:
 - \$7,661 net operating surplus (target is break-even)
 - Operating revenue of \$146,167 represents an increase of \$20,074 or 16% vs. PY
 - Sail Camp +\$6,945
 - Day Camp +\$6,005
 - Advertising +\$6,335
 - Operating expenses increased \$31,273 or 29% vs. PY
 - Deck over old dock house foundation: \$13,686
 - Day Camp: \$7,823
 - Sail Camp: \$8,196



Treasurer's Report

Alan Stratton, Treasurer

- Strong financial position at December 31, 2022:
 - \$172,298 net liquid assets
 - Current ratio of 8.5:1.0
- Fund balances:

Operating (unrestricted): \$57,878, net of land & buildings

• Community Centre Fund: \$78,713

Contingency Fund: \$40,635

• Dock Fund (new in 2022): \$12,000

- Off balance sheet fund balances at Township of the Archipelago:
 - New Building Fund: \$147,389 (+\$83,045 vs. PY)
 - Sport Court Fund: \$2,863 (no change)

- Effective July 1, 2023, SSCA has joined the Federation of Ontario Cottage Associations (FOCA)
 - Each SSCA member is a member of FOCA
 - The voice for 250,000+ waterfront property owners across 525 lake & road associations
 - Strategic priorities:





Property Update Glen Campbell

- New property operating model
 - Tennis facilities managed by SSTC
 - SSTC / SSCA agreement being revised
 - Targeting \$30,000 annual set-aside for facilities repairs and reserves
 - SSTC summer staff responsible for property as well as programs





Revitalization Programme Recap


We are:

- Begins at the end of this season.
- Project design and management by Jackie Koza








Revitalization Capital Costs

- Existing facilities renovations \$0.5m
 - School house
 - Boathouse/storage/fitness
 - Shoreline decks/docks
- New community centre \$1.5m



Capital plan is flexible and scalable: Funds go to renovations first and then to new construction. New building budget and detailed design will depend on funds raised.



Community Centre Revitalization Campaign

Eric Armour

- Campaign target is \$2 million
- Donations and pledges to date: \$1.1 million
 - 43 donations received, including
 - 3 at \$100K +
 - 6 at \$30K-\$100K
 - 10 at \$10K-30K
- Canadian tax receipts are being provided by the Township
- US donors can get a tax receipt through CAF
- We have reached out to 81 members to date, and will reach out to all members this year

Purpose of By-laws

Conservation of the **overall natural landscape** and **waterscape**, including habitats of threatened/endangered species.

Preservation of the **natural appearance**, **character**, **and aesthetics** of The Township, including changes to the vegetation and grade of land.

Preservation of the high-quality recreational character and natural environment.



Prohibitions

Prohibit a person from undertaking any site alteration or injury or destruction of trees, unless exempted by by-law.

Site Alteration:

A change in elevation from existing grade or finished grade resulting from (a) placing or dumping of fill, (b) removal of top soil, (c) placing, dumping, removal or blasting of rock, or (d) any other action that alters the grade of land, including the altering in any way of a natural drainage course on a site.

Prohibitions



Prohibit a person from undertaking any site alteration or injury or destruction of trees, unless exempted by by-law.

Tree Preservation:

- "Destroy" means any action which causes or results in the irreversible injury or death of a tree and/or native shoreline vegetation, by cutting, burning, uprooting, chemical application or other means.
- "Injure" means to do harm, damage, or impair.
- "Tree or Healthy Tree" means any living species of a stemmed perennial woody plant, with a diameter at breast height of 15.24 cm (6") or greater, located on any lands within The Township.
- "Native Shoreline Vegetation" means vegetation (i.e., any woody plant, or contiguous cluster of plants including, but not limited to, trees, shrubs, and hedgerows) comprised of plant species, other than invasive species or noxious weeds, that are indigenous to the Township, and which reasonably could have been expected to naturally occur on lands, and which are located within 30 m (98.43 ft) of the highwater mark of any navigable waterway.

Prohibitions

Where site alteration is exempted by the by-law or where relief is granted to the owner, no person shall undertake site alteration which may result in:



Adverse erosion and environment impacts on and off site.



Siltation in a watercourse, wetland, or storm sewer.



Transportation of silt to adjacent, neighbouring, or downstream properties.



Detrimental effect on the quality and quantity of water in a well.



Blockage of a swale, ditch, or waterway.



Flooding or ponding on adjacent lands.



Pollution of a waterway.



Unauthorized injury or destruction of Township trees or other protected trees.



Detrimental effect on matters of inherent biological sensitivity.



A detrimental effect on areas of archaeological significance.



Detrimental effect on any trees of a caliper of 15.24 cm (6") DBH or more located on the lands.



A detrimental effect to the growth and/or harvest of fruit, vegetables/crops, landscaping, gardens.



A detrimental effect to the visual amenities of the land such that it constitutes an unreasonable interference with the enjoyment of property.

Exemptions to By-law

Example Site Alteration Exemptions

- Maintenance or replacement of existing features (i.e., landscaping, driveways, parking areas, patios, stairways, walkways, retaining walls, picnic table platforms, firepits).
- Activities required to install, expand, repair, or maintain an approved septic system.
- Necessary for the installation of a foundation for a building/structure or within 5 m of any building/structure where a Building Permit has been issued.
- Required for the installation of a driveway to a building/structure where a Building Permit has been issued.
- Temporary access road for properties that are only accessible by water.

Example Tree Preservation Exemptions

- Removal of trees to permit view corridors and access to the shoreline.
- Activities required to achieve an approved building permit.
- Required for the installation of a driveway to a building/structure where a building permit has been issued.
- Activities required to install, expand, repair, or maintain an approved septic system.
- Activities required for good arboricultural practices.
- Activities required for good forestry practices.
- Activities required for emergency works.
